

# 2017 Membership Offer

## New and Existing Members\*\*

The object of this offer is to increase membership by providing existing members a discount if they bring-in/sponsor new members, and also by offering discounts to new members. This offer is applicable to new golf members, but excludes new Social/Pool memberships. Any existing member can sponsor/bring-in new members (no limit) and receive a credit on their membership fees. The credit the existing member receives is 5% of the value of the membership price of the new member. In other words like in previous years, if you bring-in enough new members you could get yours membership “free”. This offer is good until 1 February 2017. Please note that in addition to the discount the existing member receives, the new member receives a 10% discount to their first year membership and we will waive the \$125 initiation fee. Below is an example of the benefit to the existing and new member.

### **EXAMPLE:**

*In this example an existing full family member sponsors/brings-in a new single golf member*

#### **Existing Member**

Without new member - Existing Family Membership - \$1,795 less 3% early pay discount = \$1,741.15 (\$53.85 savings)

With new member - Existing Family Membership - \$1,795 less 3% early pay discount = \$1,741.15. In addition the existing member receives an additional credit of 5% of the value of the new single membership price, or in this case \$54.75 (\$1095 X 5%) thereby reducing their full family membership to a total of 1686.40 (\$108.60 total savings)

#### **New Member**

New member - Single Membership - \$1095 +\$125initiation fee = \$1,220 less waived Initiation Fee \$125 and 10% new member discount = \$985.50 (\$234.50 savings).

\*This only applies to the Golf Membership fees and sales tax of 7% will also still apply.

All Memberships both new and existing that are paid in full by February 1<sup>st</sup> 2017 will also still receive 4 guest passes for golf in the 2017 season.

\*\* Existing Member is defined as anyone who was an Indian Creek member in 2016.

Referral discounts provided as a credit in your April 2017 bill. Please have new members write referral on the line provided on the application.
