

2018 Membership Offer

New and Existing Members**

The object of this offer is to increase membership by providing existing members a discount if they bring-in/sponsor new members, and also by offering discounts to new members. This offer is applicable to new golf members, *but excludes new Social/Pool memberships*. Any existing member can sponsor/bring-in new members (no limit) and receive a credit on their membership fees. The credit the existing member receives is 5% of the value of the membership price of the new member. In other words like in previous years, if you bring-in enough new members you could get yours membership “free”. This offer is good until 1 February 2018. Please note that the *new member receives a 10% discount* to their first year membership and we will waive the \$125 initiation fee. ***All discount credits will be applied to member accounts in once membership is paid in full.*** Below is an example of the benefit to the existing and new member.

EXAMPLE:

In this example an existing full family member sponsors/brings-in a new single golf member

Existing Member

Without new member - Existing Family Membership - \$1855.00 less 3% early pay discount = \$1,799.35 (\$55.65 savings)

With new member - Existing Family Membership - \$1,855 less 3% early pay discount = \$1,799.35. In addition the existing member receives an additional credit of 5% of the value of the new single membership price, or in this case \$56.75 (\$1135.00 X 5%) thereby reducing their full family membership to a total of \$1742.60 (\$112.40 total savings)

New Member

New member - Single Membership - \$1135 +\$125 initiation fee = \$1,260 less waived Initiation Fee \$125 and 10% new member discount = \$1021.50 (\$238.50 savings).

*This only applies to the Golf Membership fees and sales tax of 7% will also still apply.

All Memberships both new and existing that are paid in full by February 1st 2018 will also still receive 4 guest passes for golf in the 2018 season.

** Existing Member is defined as anyone who was an Indian Creek member in 2017.

All discounts will show up as a credit once membership is paid in full. Please have new members write referral on the line provided on the application.
